CONTRACT FOR SALE OF FRANKLING SCHOOL

Board Attorney Leon Stone explained that the agreement with Milestone Ventures, LLC is to sell the former Franklin School building and property at \$50,000 of which \$1500 will be paid up-front. This sale price is above appraisal value of the property. The agreement allows them to withdraw from the contract up until July 1, 2018, with closing on the building to occur by July 1, 2019. The current tenant will continue to lease the property until the sale closes. Upon a motion by Nolcox and second by Rogers, the board unanimously approved the contract for sale.

OTHER

Assistant Superintendent Goggins recognized Kevin Whitten and Mary Lumsdon as the Standing Ovation Award winners for month of November. Both are employed at Princeton Community Middle School.

REPORTS

Assistant Superintendent Goggins shared information with the board about the new State Board of Education approved graduation pathways. He shared his concern about meeting the pathways for small and medium sized school districts. He also shared that these new pathways are going to be very demanding of guidance counselors for tracking student success and may require consideration of additional staff.

PATRON STATEMENTS

There were no patron statements during this regular board session.

BOARD MEMBER CONCERNS

Iunghuhn shared that North Gibson will be speaking at an upcoming County Commissioners meeting regarding a proposal for an addition to Princeton Community Primary School. They will be requesting \$4

million in TIF funding along with \$5 million of funding coming from North Gibson.
